# A Necessary “Evil”

- Although it may be seen as immoral to scare children, **it would be more unethical to leave the entire city of Monsteropolis without power**
- Before the discovery of laughter as an energy source, scaring children was the only way to keep Monsteropolis and the greater Monster society functioning
- It was clear the city was incredibly dependent on the energy from screams. Cutting off scream energy (when they were unaware of the power of laughter) would have been catastrophic
- For an idea of what cutting power could do to Monsteropolis, just look at Texas. When winter storms resulted in a loss of power, between 200 and 700 people were killed — energy is vital to society

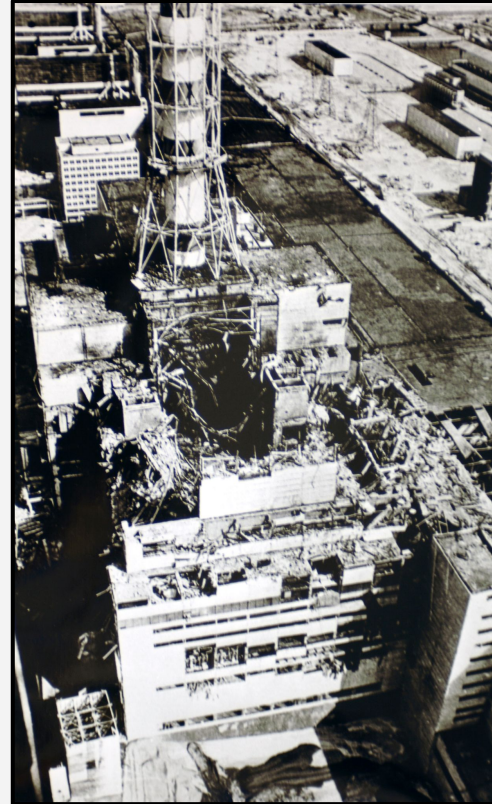
# An Incredible Source of Power

- Even assuming the absolute worst case scenario human screams are an incredible source of energy.
- Assuming 1000 kids per night, 1 canister per child on average, and powering only the immediate city.

$$\frac{600,000 \text{ MWh}}{365 \text{ Days}} \approx 1644 \frac{\text{MWh}}{\text{Day}}$$

$$1644 \frac{\text{MWh}}{\text{day}} / 1000 \frac{\text{kids}}{\text{day}} \approx 1.64 \frac{\text{MWh}}{\text{kid/scream}}$$

- This is comparable to the energy of 1g of uranium, 3 tons of coal, or 600 gallons of fuel
- This is the equivalent energy required to power a family home for a month
- Makes real-life energy sources look primitive
- *It would be stupid not to use this safe, environmentally friendly, and spectacularly efficient energy source!*



# The Need for Energy is of Critical Importance

- Humans are a lesser species; human children are at the whim of Monster society
- Collecting children's screams gives the city power in all sectors
- Human children are NOT monster children
- Monsters need to scare human children just as humans raise livestock to later be eaten and/or use their resources.



# We Find 'Worse' Things Acceptable

- Do you eat meat? **If so, you believe that morally debatable practices for necessary goods are acceptable**
- An overwhelming majority of the world — 86% — eats meat. While killing animals is a sad truth of society, it is necessary for society to function
- In comparison, scaring children is relatively benign
- If factory farming is ethical and acceptable because it is necessary, scaring, which is not nearly as bad, must also be ethical



86% of the world eats meat.

That means that over 6 billion people accept the process of killing animals to eat meat, because meat is necessary for society.
